If the tenant gives notice to quit before the last day, the landlord will keep the rent deposit as compensation. A notice to quit must be made in written form. The landlord and tenant can give notice to quit with the reasons defined in the Finnish law (31.3.1995/481).

This payment will be returned within 2 weeks after the last day of the rental time, if the tenant has not caused abnormal damage for the rented subject. The rent deposit must be paid a week before the first day of the rental time. The rental agreement will be dissolved, if the rent deposit is not paid according to these rental terms.

## Price increase

If needed the landlord can change rental price a year after the first day of the rental time or when the rental contract is extended. Increase the price is also possible with an agreement by the both landlord and tenant, when the standard of service increases.

## Other rental terms

Smoking and animals are not allowed inside the house as a courtesy to other tenants.
Normal living duties, cooking, laundering, cleaning, dish washing, waste handling etc., belongs to the tenant. The tenant must buy foodstuff and laundry detergent by her/himself.
The tenant has gotten 1 key. The tenant will pay 30 € per lost key.
